

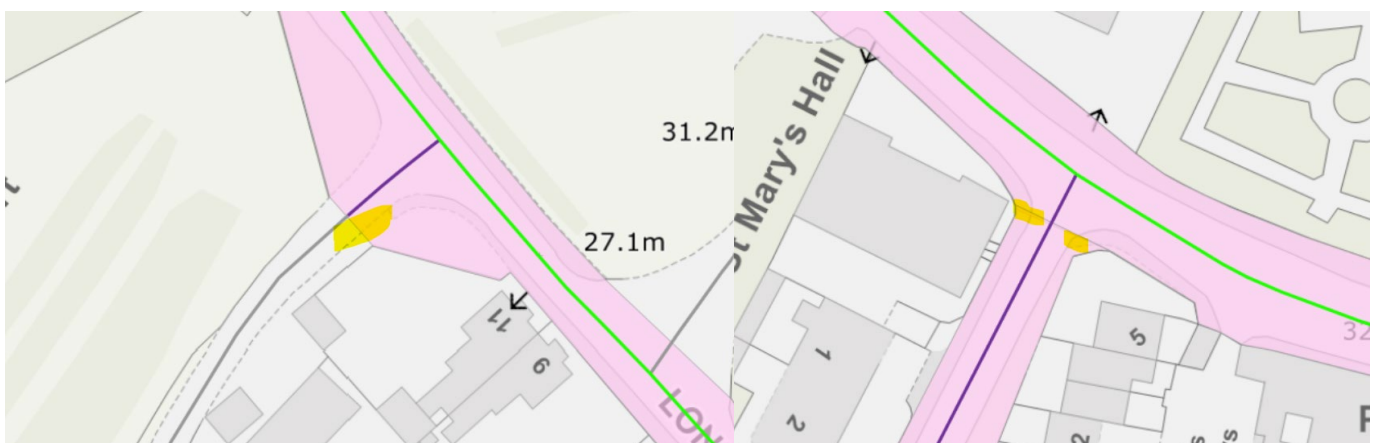

West Sussex County Council, in its capacity as Local Highway Authority (LHA), have been re-consulted on proposals for 6 x dwellings and associated works. In comments dated 10 October 2025 the LHA requested further information regarding exploring tactile paving improvements (potentially Mount Pleasant) and confirm with certainty whether Anne Howard Gardens will be proposed for adoption, as well as exploring improvement to the existing full height footway where it transitions to shared surface.

The applicant has agreed to tactile paving at Mount Pleasant/London Road junction, has confirmed that Anne Howard Gardens will remain privately maintained and has agreed to a kerb transition from the full height footway/kerb on southern side of junction Anne Howard Gardens to the shared surface carriageway.

The applicant should design and deliver the dropped kerb/tactile paved crossing of Mount Pleasant/London Road and the footway/kerb transition in to Anne Howard Gardens. Please ask the applicant to provide a plan detailing these works which can then be secured by condition and delivered via minor works licence.

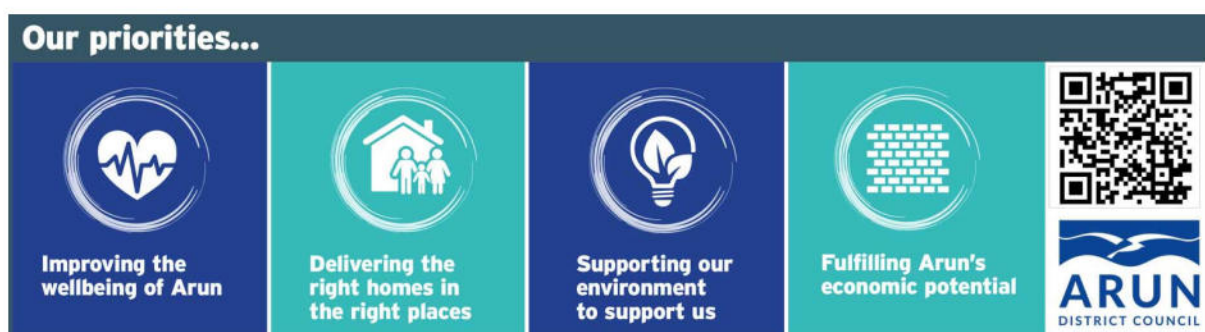
