Description of works: Proposed erection of 8 No. signs and 4 No. flags.

Thank you for your internet representation made on 31st October 2025 which has been recorded as an objection with the comments as follows:

OWPC79576

My objections to the advertising signs, which were installed without any prior consultation, are with reference to the HM Gov Dept for Communities and Local Government publication 'Outdoor Advertisements and Signs'. In this the basis for how consent is decided is on Amenity and Public Safety.

i) Amenity. The positioning, quantity and sheer scale of the signs has a substantially negative affect on the visual amenity of immediately neighbouring properties, of which e are one, plus passers-by at this rural location and gateway to Historic Arundel.

ii) Safety. By virtue of their locations and size, they are designed to attract the attention of passing vehicles (there are no footpaths along Ford Road at this point). Consequently they are a distraction hazard to drivers on a 60mph limit road in the immediate vicinity of an increasingly busy T-Junction.

Your views as made above will be considered before the application is determined.

Please be aware that Planning Services operate an 'open file' policy and will publish your comments including your name and address on the website. Any comments that are received after the agenda has been finalised will be separately reported to the members of the Planning Committee.

Regardless of how the application is determined I will notify you of the decision.

In the event of a subsequent written representations appeal, against a refusal of advertisement consent any representations made on the application will be automatically forwarded to the Secretary of State. Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
