Details of the pre-application advice received

The dwelling is a walkable distance to the BUAB as a result of a revised settlement boundary in the Arundel NP to incorporate a 90 housing development directly to the north. The development would contribute 1 additional housing unit with associated, albeit small scale, social and economic benefits. The proposal meets the economic, social, and environmental aspects of sustainable development and the presumption in favour of sustainable development is engaged.

The design has been amended following advice from an earlier pre-app. The design proposes a traditional styled building which would appear in keeping with neighbouring buildings, particularly with that 'Hanger Down House' and its wider setting. Materials are noted as brick and flint elevations with clay tile hanging and timber windows which would appear acceptable.
