Dear Ms Guilbert,

I write to you with respects to the above application.

Following the previous planning appeal decision (APP/C3810/D/24/3339003) and notwithstanding The Local Planning Authority's sole reason for objection under AB/117/23/PD, the Planning Inspector found that there were additional components of the proposal that did not comply with the relevant criteria of Schedule 2, Part 1, Class AA. Notably, he Inspector identified that the single storey front bay, rear two-storey bay, and the single-storey front lean-to do not form part of the principal part of the dwellinghouse. As such, they concluded that these components prejudiced the schemes compliance with Class AA. I do note that the additional storeys above the garage have now been removed to address our prior concerns, but I also note that the additional two storeys continue to apply to the bay and lean-to features. As such, as the proposal stands, it remains non-compliant with the relevant sections of Class AA.

I also note that The Inspector found some inaccuracies in the existing elevations, these being the lack of a pitched roof to the rear tow-storey bay feature and the absence of the French doors to the front and rear central gables of the roof.

I would ask that the existing and proposed elevations be amended to remove the additional storeys from the bay and lean-to features identified by The Inspector, and to ensure the minor inaccuracies identified are addressed accordingly. Provided these amendments can be made by 09/05/25, we will have them uploaded and consider them further within our assessment of the application. In lieu of these amendments, it is clear that the proposal should be 'refused' in its current format in line with the prior conclusions of The Inspector.
