Description of works: Conversion of existing single residential unit with associated commercial space to form 3 No. residential units together with associated works and rear/side extension. This application affects the setting of listed building, affects the character and appearance of the Arundel Conservation Area, is in CIL Zone 2 and is CIL Liable as new flats.

Thank you for your internet representation made on 20th February 2025 which has been recorded as an objection with the comments as follows:

Having looked at submissions from residents and also from WSCC Highwsys (February 5th) I am further concerned about this application on 2 more grounds. Has the planning application been properly and permanently advertised and flagged up since January 30th? I ask because it seems very odd that it has only been in the last couple of days that residents have been responding to the application making me wonder what happened to the publicity surrounding the application before 17th February? Secondly I was staggered to read the submission by WSCC Highways that even though the development would require at least 8 extra parking spaces on the street that there would be no parking capacity issues arising from the development. Anyone who knows Arundel and the constant issues and problems of parking for residents would see this as an absurd observation. I would suggest a visit to Arundel would quickly illustrate that accommodating a further at least 8 cars on the street would clearly create further totally unnecessary parking issues for residents. WSCC requiring covered and secure accommodation for bikes rather than provision for at least 8 car parking spaces seems a trivial recommendation with little concern for real issues affecting the residents and businesses of Arundel.

Your views as made above will be considered before the application is determined.
