The proposed installation would be conducted by Octopus Energy and comprise 13 x JAM54D41 LB solar panels (5.655kW of Solar Power, 435 Watt panels, and 6186kWh per annum). Supported by an Emphase IQ8AC Microinverter (0.36kW AC), an Emphase IQ Battery 5P (5.0kWh, 3-2 kW AC), and a 30m Solar Panel Bird Exclusion Kit. The battery would be located on a west facing wall of the property's private garden.
