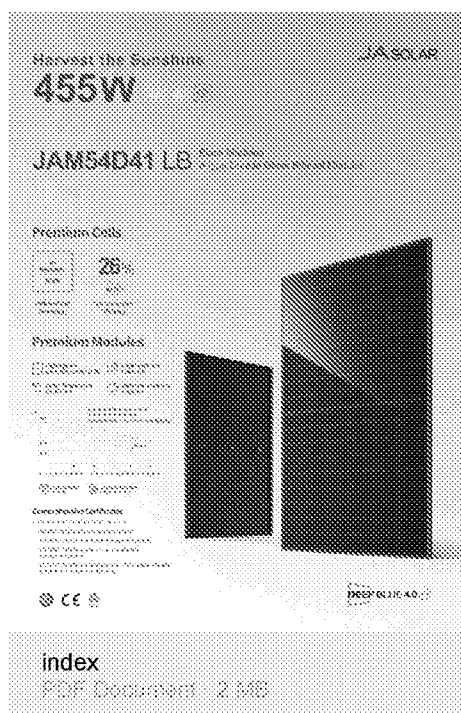

This is problematic as the General Permitted Development Order which this application is assessed against, states solar thermal equipment cannot protrude more than 0.2m beyond the roof slope.

Please can you confirm you can amend the choice of solar panels, so that they comply with the 0.2m depth. Please provide amended plans so that we can continue with the application.
