A resident has written to state that the plans are inaccurate as not all nearby buildings are shown. Whilst this was not a validation requirement, I can see that there are differences between our OS mapping and your location and block plan including that a dwelling immediately adj the northern boundary (The Old Stables) is not shown. Also, other dwellings are not drawn to their correct shape. This may affect the assessment of impact on other buildings. I would therefore request that you provide an updated version of the plans please.
