Description of works: Demolition of existing tennis court and erection of a commercial building (within Use Class E(g)), parking, landscaping and other associated works. This application is a departure from the Development Plan, may affect the character and appearance of the Norton Lane, Norton Conservation Area and is in CIL Zone 3 (Zero Rated) as other development.

Thank you for your internet representation made on 19th November 2025 which has been recorded as an objection with the comments as follows:

OWPC79897

Norton Lane is a narrow and rural road with no public transport facilities. It is much used by walkers, some of whom are elderly. This development will generate increased traffic of a hazardous nature. The road is also unlit at night (ref EH 10) The development also falls outside the Built-Up-Area Boundary(EH1) and is completely out of character with its rural surroundings. I have previously objected to similar planning applications which have been overturned on similar grounds.

Your views as made above will be considered before the application is determined.
