Your appeal (under Section 195 of the Town & Country Planning Act 1990) would be that the Council has failed to make a decision and you would be asking a Government Planning Inspector to make the decision instead. If you allow the Council extra time to make a decision on your application, and you disagree with the decision, you will still be able to appeal the decision.
