Once again, I object to this planning application. I still cannot see how sending at least another 89 vehicles out onto the A29 near a blind bend makes any sense. It is a recipe for disaster. The roads are already over burdened with traffic. The doctor's surgery and the schools cannot cope with more people coming into the area. The sewerage system cannot cope with more concrete stopping ground water having to find other ways of draining which will lead to even more flooding in the area. Please don't let this development go ahead.
