Approval of reserved matters following outline consent AL/178/22/OUT for appearance, landscaping, layout and scale for 89 No. dwellings with open space and associated works (resubmission following AL/50/24/RES). This application is in CIL Zone 3 and is CIL Liable as new dwellings.

The outline planning permission (A/178/22/OUT) Appeals Decision Notice APP/C3810/W/23/3323858 includes conditions (conditions 11) and 12) related to the submission of full details of the proposed surface water drainage scheme and implementation for the development. This response therefore assumes that these conditions is still to be discharged therefore we recommend discharge of these prior to discharging this application.
