Thank you for your internet representation made on 5th February 2025 which has been recorded as an objection with the comments as follows:

Sundew which is in the lane (know as the Cinder Path)bordering the proposed development has been our family home for seventy years .

Being a single story building we believe that the development will completely overshadow us and take our light.We are already surrounded at the back and side by tall buildings.

There is considerable noise pollution already with motor bikes and vehicles revving engines and screeching away at speed so my concern is that if the new developments goes ahead it will be a double whammy.

The proposed site has flooded for many years now and the end of Hook Lane at the Woodgate end has in recent years begun to flood considerably. It would appear that the sewers are overwhelmed and unable to cope with even more water.

The infrastructure for the surrounding area does not have capacity to accommodate the 89 dwellings/ residents . Schools, doctors, dentists etc are completely overwhelmed already.

The dangerous road conditions at the Westergate Street / Meadow Way junction are of grave concern. Trying to exit from there or from Hook Lane on to the Main Street is difficult at best- dangerous most of the time. Residents in Meadow Way and for us residents in the CinderPath are basically having our lives turned upside down by this proposed development being in such close proximity to us and also having to navigate our way around the extra problems that this brings with it.

I remember back in the day when the small holder was refused planning for greenhouses on the land to grow food. Here we are 50 years down the line and being faced with 89 dwellings . Seems ludicrous to me.

I understand that the council are not interested in the devaluation of our properties that this will cause, but

finding a buyer in the first place who sees the benefits of houses looming over a single story bungalow is something else.

Your views as made above will be considered before the application is determined.
