Thank you for your internet representation made on 23rd January 2025 which has been recorded as an objection with the comments as follows:

OWPC73775

I am writing regarding the above application; I understand there is a proposal to connect the foul waste from the housing development to an existing drain. The drawings detail 9 existing properties currently connected to the foul waste drain with the proposal for a further 95 houses in phase 1 and potentially a further 155 houses with phase 2.

To increase the flow from 9 to 250 homes represents an increase of 2877% or more, seems to be a questionable and inappropriate professional option.

Whilst I do not profess to be a specialist in this field, it is clear that the proposed route via the existing drains could easily overwhelm the system, causing unnecessary contamination.

I assume there are more appropriate options to route considerable foul waste from the new sites and accordingly rely upon Arun Council to ensure these concerns are dealt with professionally and with consideration to the existing local families.

Your views as made above will be considered before the application is determined.
