**RE: AL/143/24/RES - Land adjacent to Woodgate Nurseries, Lidsey Road, Aldingbourne, PO20 3SU**

Thank you for your consultation on the above site, received on 15 January 2025. We have reviewed the application as submitted and wish to make the following comments.

This is an application for Approval of reserved matters relating to Approval of reserved matters following outline consent AL/129/21/OUT for 95 No residential dwellings with associated parking, landscaping, open space (including play areas), infrastructure and works. This application is in CIL Zone 3 and is CIL Liable as new dwellings.

We recommend **objection** to this planning application in the absence of an acceptable Flood Risk Assessment (FRA) and Drainage Strategy relating to:

- Further information required/updated to demonstrate method of surface water discharge.
- Not complying with NPPF, PPG or local policies.

**Reason**

To prevent flooding in accordance with National Planning Policy Framework paragraph 173, 175 and 180 by ensuring the satisfactory management of local flood risk, surface water flow paths, storage and disposal of surface water from the site in a range of rainfall events and ensuring the SuDS proposed operates as designed for the lifetime of the development.

**We will consider reviewing this objection if the issues below are adequately addressed.**

1. **Updated FRA and Drainage Strategy (Phased Reports) presented for consideration with appropriate plans at FOR CONSTRUCTION status**

- 2. Revise Calculations to current standards (eg FEH2022, CV=1 both Summer and Winter, ensure storage quoted can be achieved.**
- 3. Sufficiently legible documents and plans provided. There are some resolution issues of the documents on the Planning Portal**
- 4. Recommend Phases System reviewed/approved together and in conjunction to the discharge of Outline conditions 16-18 contained within Decision Notice AL/129/21/OUT**

Please note if the LPA decide to grant planning permission, we wish to be notified for our records should there be any subsequent surface water flooding that we may be required to investigate as a result of the new development.
