Thank you for your internet representation made on 17th November 2025 which has been recorded as an objection with the comments as follows:

The CIL documents seem incomplete?

So far we have enjoyed privacy & peaceful existence with open views of surrounding countryside, as per Policy D DM1 as we enjoy not being overlooked this will end and unnecessarily. This development will not enhance the amenity of local residents but rather an overdevelopment of Garden land & will create vehicular noise at all hours and invade our privacy whilst enjoying our property. The development of this house cannot be necessary or contribute to Arun's shortfall in housing due to all the large developments in the locality there can be no shortfall. The noise from development will be a nuisance and as self build may well take longer than normal for such a development. I ave always been concerned by new housing removing natural drainage creating a potential for local flooding and as currently I only suffer minimal soaking of ground at lower end of garden I will be somewhat dismayed if that changes because the proposed plot offers to infill a sizeable piece of natural drainage. At present there is no noise at the rear of our property this development will completely change that due to vehicular noise and vehicle lights at night, what in the planning is designed to control that? Back in 2013 I note you imposed conditions on this same property associated with a garage not to be used as accommodation now you want to put a 4 bed house there??? The Privacy of adjoining occupiers should be maintained.

Level Mare Lane has already been decimated by the developers of Bayards at the junction with Fontwell Avenue and as yet remains a hazard to all who venture here.

I therefore request this application be rejected and Arun review their own policies which support our arguments against Environmental disturbances, quality, noise, & privacy.
