Description of works: Part single, part two storey side and rear extensions, conversion of garage to habitable use, hip to mansard roof extension with dormers, and alterations to fenestrations.

Thank you for your internet representation made on 4th February 2025 which has been recorded as an objection with the comments as follows:

OWPC74046

This is a Private Road. Owners are encouraged to Park "off Road."

There have been rumours that No 27 will be used as an Airbnb at various times, and therefore parking for at least five cars could be required. (5 large bedrooms, with 3 ensuite and room to expand)

Bearing in mind that the double garage has been changed to a Study, Plant room, Wine Store and Cinema, the plans do not indicate off road parking availability.

Your views as made above will be considered before the application is determined.

In the event of a subsequent written representations appeal, against a refusal of planning permission on a householder application any representations made on the application will be automatically forwarded to the Secretary of State. Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
