Description of works: Part single, part two storey side and rear extensions, conversion of garage to habitable use, hip to mansard roof extension with dormers, and alterations to fenestrations.

Thank you for your internet representation made on 5th February 2025 which has been recorded as an objection with the comments as follows:

The plan indicates that the existing garage will be used for habitation. There is limited parking on the plot in front of the garage and the road outside the plot is already full of parked cars. I object on the basis that this planned work will increase parking congestion where there is already friction and some unrest between neighbours with existing parking arrangements.

In the event of a subsequent written representations appeal, against a refusal of planning permission on a householder application any representations made on the application will be automatically forwarded to the Secretary of State. Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
