My husband and I wish to object to the above application for building works at 9 Tinghall, PO21 3RJ. because of the impact this would cause on our small community with the lack of parking for work men'vehicles who are doing extensive work over a prolonged time in a confined area.

The communal grassed area may become damaged and the impact to the residents of this area, which we all enjoy, especially in the summer months, would be greatly disturbed, also when the works are completed the new occupants would obviously have a number of vehicles in an already limited parking area.
