The proposed replacement of existing timber windows with uPVC will result in a small reduction in microhabitat availability for insects and other invertebrates. Given the minor scale of the change and the limited outdoor space on site, no direct mitigation measures are feasible. The impact on local biodiversity is therefore expected to be low and not significant.
