Thank you for your internet representation made on 30th November 2025 which has been recorded as an objection with the comments as follows:

The proposed extension will be 1.2m above my fence at the complete edge of it. Light is limited already due to the building being North facing. This will obscure and limit the amount of light I have in my property and devalue it. I have spent thousands of pounds already on french doors and a larger window to enhance the light. The height of the extension and closeness will cause major issues with light being able to enter my property. It will cause a corridor bereft of light and also impact on all our plants.

Your views as made above will be considered before the application is determined.

In the event of a subsequent written representations appeal, against a refusal of planning permission on a householder application any representations made on the application will be automatically forwarded to the Secretary of State. Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
