Dear Gary,

Sorry, but further to my message on Monday, our Group Head of Planning has now said that if we are 100% certain that you will withdraw then its ok to leave it running but we need certainty that it won't go past time. So, can you either withdraw this week or provide an email that states that if the application is not ready to be determined by the 14 March 2025 determination date, then you would request it be withdrawn before that date.

We received Highways comments yesterday stating:

"I see that the site to the north (A/122/19/OUT) has a condition for the developer to deliver a signalised crossing just south of the primary school on Arundel Road. This is in very close proximity to the proposed site access works proposed for the above application. It says the crossing should be delivered by the 80'th occupation of the new residential units. Could you confirm how far off this is please, do you know how many are already built out and how many are occupied? So, I can gain an idea of when this is likely to be put in place.

I have reviewed the application now, but we will need for the Safety Auditor to be made aware of the signalised crossing that is secured and going to be in place given its proximity to the new access point for the Angmering Sports Hub, I would need the following provided –

- *A new site access plan that also details the secured signalised crossing point and the proposed new access, with the proposed parking restrictions (double yellow lines) included on the plan, that the Safety Auditors have recommended.*

- A revised/updated Stage 1 RSA that confirms that the Auditors are aware of the signalised crossing and have reviewed the new access now taking account of the crossing too.
- A RSA Response Report in line with GG 119 Appendix F (see attached) the LHA will require an editable version of this to complete our sections as overseeing authority.

I have included the signalised crossing plan details above to for information.”

I have advised WSCC that as of a site visit on 09/01/25, there were no occupations.

We are still awaiting comments from our Tree Officer, Economic Regeneration, WSCC Waste and Angmering Parish Council. Of those, the only one I would consider important would be the Tree Officer.

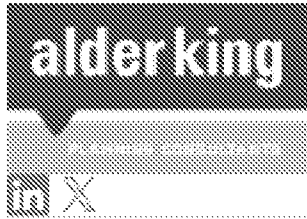
