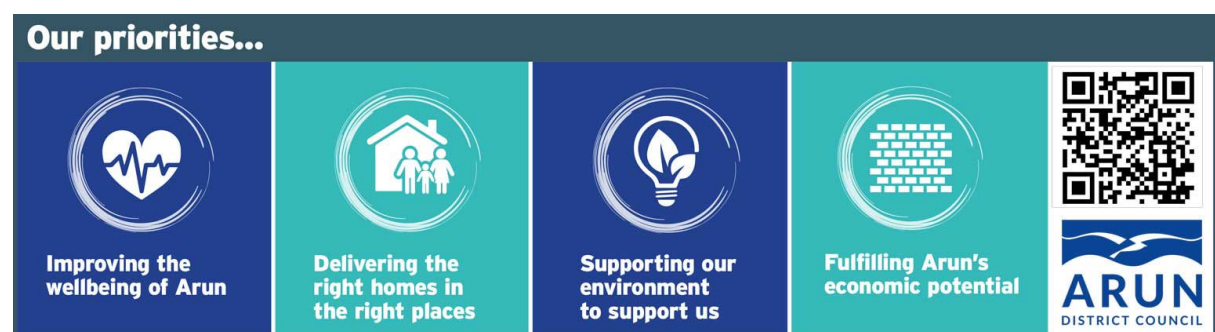

Planting detail has been submitted under Hard and Soft general arrangement dwg LLD1275-LAN-DWG 100 05, Soft Landscape layout LLD1275-LAN-DWG 200 04, Detailed planting plans LLD1275-LAN-DWG 201-204 Rev 04 and detailed plant schedule and specification LLD1275-LAN-SCH-001.

Detailed information is included within the submitted Ecological and Landscape Management plan which covers operation and timings but does not detail responsibility, assumed Management Company. The information provided has included maintenance operations for a 5 year establishment period.

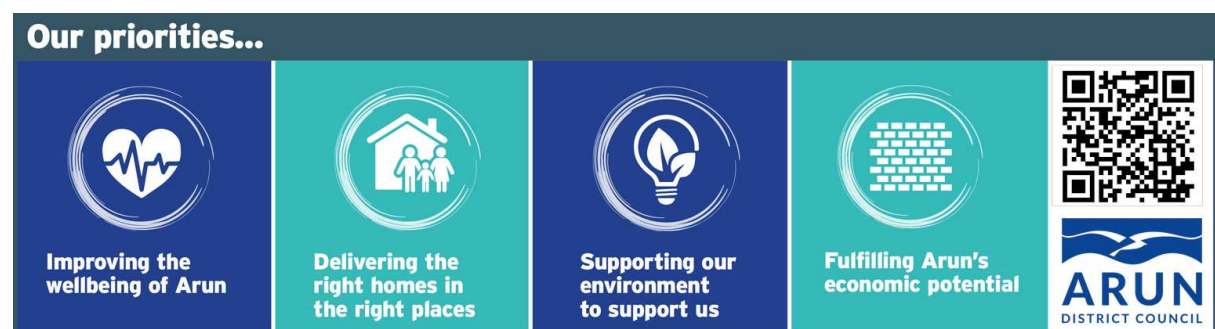
