I just wanted to provide an update on the AOO application for Manor Nursery (A/38/25/AOO) as I note the expiry for this application is today. As this application is related to the current Deed of Variation we have in at the moment (in that both are related to wording and schedules surrounding Public Open Space), we feel it would be best to hold the determination of this application until the DoV has been completed under A/45/25/DOV. This is to ensure that no details are approved prematurely; and as such avoid any issues which may arise by altered wording in the DOV. In addition, we are still awaiting comments from our landscape officer; I have chased these, and am hoping to have an update soon.

I will be chasing Legal also for an update on A/45/25/DOV, as I note this is taking some time to resolve their end.

In light of the above, please could we request an initial extension of time for A/38/25/AOO to the 7th May, to give some additional time on to get comments from the landscape officer, and resolve the decision for A/45/25/DOV (due also on 7th May)?
