Thank you for your application which was received on 5th March 2025. I am writing to acknowledge that it was accepted as a valid application on 17th March 2025. The Council aims to make as many decisions as possible before the end of the statutory determination period, which in this case will be 12th May 2025. However, this is not always possible for a number of reasons, including on-going negotiations or the scheduling of Planning Committees.

If you have not received a decision by 12th May 2025 or agreed in writing to extend the time in which the Council make a decision, you have 6 months in which to appeal to the Secretary of State. Your appeal (under Section 78 of the Town & Country Planning Act 1990) would be that the Council has failed to make a decision and you would be asking a Government Planning Inspector to make the decision instead. You can do this on a form which you can get from the Planning Inspectorate:

If you allow the Council extra time to make a decision on your application, and you disagree with the decision, you will still be able to appeal a refusal within 12 weeks from the date the decision was issued or if appealing a condition 6 months from the date the decision was issued.

Please be advised that the Council adopted the Arun Community Infrastructure Levy (CIL) Charging Schedule on 15 January 2020. The CIL Charging Schedule came into effect on 1 April 2020. This application may be CIL Liable and you are advised that you need to complete an assumption of liability form or any appropriate exemption or relief forms available on the Council's website.
