Thank you for your application which was received on 18th February 2025. I am writing to acknowledge that it was accepted as a valid application on 3rd March 2025. If you have not received a decision by 2nd June 2025 or agreed in writing to extend the time in which the Council make a decision, you have 6 months in which to appeal to the Secretary of State. Your appeal (under Section 78 of the Town & Country Planning Act 1990) would be that the Council has failed to make a decision and you would be asking a Government Planning Inspector to make the decision instead. You can do this on a form which you can get from the Planning Inspectorate:

If you allow the Council extra time to make a decision on your application, and you disagree with the decision, you will still be able to appeal within 6 months from the date the decision was issued.

You will need to carry out your own checks to determine whether any other consents or permissions are required.
