RE: BE/16/25/RES – Land at Oldlands Farm, Newlands Road, Bognor Regis, PO22 9NN

Thank you for your consultation on the above site, received on 10 June 2025. We have reviewed the application as submitted and wish to make the following comments.

This is a reserved matters application for the approval of reserved matters following outline consent BE/150/22/OUT comprising of 3 No. units within Class B2 and/or B8 of the Use Classes Order (including ancillary office provision) with associated enabling works, parking, landscaping and sustainable drainage system with access off Newlands Road. This application is in CIL Zone 4 (Zero Rated) as other development.

We are **unable to recommend approval** therefore would **object in principle** until such time as sufficient information is provided in relation to flood risk and surface water drainage. We would like to draw the developers attention to our requirements contained within our Surface Management Proforma and Arun DCs Drainage Checklist

The LLFA also notes the pre commencement conditions attached to BE/150/22/OUT, namely 20 – 24 and recommend that these are addressed in combination to the above.

Please note if the LPA decide to grant planning permission, we wish to be notified for our records should there be any subsequent surface water flooding that we may be required to investigate as a result of the new development.
