Please do not build these 2 structures behind our house.

We will be overlooked as will the potential buyers. Parking will be very difficult, as there are 2 large schools within a few yards and all surrounding streets, especially Greencourt Drive get packed with cars at drop and pick up times, and any event times. This is dangerous for the children and residents. This is a valid objection. The land you want to use was previously the back gardens of 4 of the houses in Greencourt Drive and the occupants would prefer to buy it back, which would be much more sensible for families
