Good Afternoon Nick,

I've PDF'd and attached the file for the planning officer, it will make more sense to them when it gets through to their drainage team.

This is the extract from their comments, in case it gets queried again why we have included it:

5. The hydraulic calculations have not been checked as a result of item 1. However, they will need to be altered to reflect the revised scheme that is now required. Urban creep at 10% must be included, irrespective of the sites perceived constraints. A surcharged outfall must also be modelled. Ensure that the calculations reflect the invert level of the proposed flow control devices. Provide a copy of the FEH point descriptors file, so their parameters can be checked.
