Thank you for your internet representation made on 14th April 2025 which has been recorded as an objection with the comments as follows:

I wish to object for the following reasons

- the original planning was for low level lighting respecting the semi rural location. However I consider the existing light pollution excessive and damaging to wildlife. A large led screen is unacceptable in adding to the further degradation of the site.
- the commercial and housing expansion of the area has resulted in much more traffic and dangerous driving in all its forms. The A29/259 roundabout is very busy with the added vehicles from the Amazon depot which will be exacerbated by the proposed additional development of the Oldfields site. A giant moving image screen will be a potential distraction to add to the mix of dodging each other on that roundabout.

Your views as made above will be considered before the application is determined.

Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
