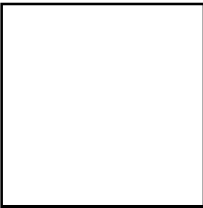
Thank you for your call and for your follow up email.

The sprinklers for the adjacent warehouse are no longer compliant, and the applicant cannot obtain buildings insurance and so the client will be undertaking a phased replacement of the sprinklers. New pumps are required as part of this work, and the existing pump house is not suitable for the new pumps, so this has to be replaced as part of these works.

The new pumps will be more efficient than the existing pumps and should therefore be quieter than the existing pumps.

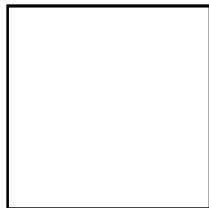
I hope you are well.
