Description of works: Erection of front link attached garage and workshop with home office above.

Thank you for your internet representation made on 11th November 2024 which has been recorded as an objection with the comments as follows:

OWPC72203

Objection to proposed garage workshop linked extension, on grounds of scale, and breach of covenant. Having previously added a 6 metre 2 storey extension to the North side of the house in 2021, adding a further 6.5 metre garage and workshop, plus a 2.015 metre link on the South side will result in a 22.7 metre long continuous building, which is excessive on a domestic plot.

Furthermore, there is a covenant dating back to January 1909 when the West Barnham Estate sold the land on which No 43 is built, which states the "No building must be erected within 30 feet of the front boundary line"

The proposed garage shows a distance of 8.1 metres to the front boundary, which is within the 9.1 metres (converted) stipulated in the covenant.

Your views as made above will be considered before the application is determined.

Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
