Thank you for your internet representation made on 10th December 2024 which has been recorded as an objection with the comments as follows:

My objection. Not submitted yet

The site at 43 is being over-developed. I understand some of the neighbouring garden at 42 has been included with number 43 however both properties have been subject to significant expansion and building since the original properties were completed. The back garden of 43 has been tiled over and now has a swimming pool and associated constructions. Although I understand this does not require planning permission, I would request that it is taken into account in the consideration of the further development of the site, drainage on and from the site and that it would be a breach of the 50% development guidance.

In undertaking this and previous developments there has been a significant loss of bio-diversity. This has included the removing

native species with the resulting impact on wildlife. I have concerns about the lack of protection and habitat for the local voles and hedgehogs. This is exacerbated by possible spillage of chemically treated water. Although I live close to the property I have not seen any action to provide replacement planting for works already done and insufficient space available to provide for replanting for this planning proposal.

Your views as made above will be considered before the application is determined.

Any comments that are received after the agenda has been finalised will be separately reported to the members of the Planning Committee.

In the event of a subsequent written representations appeal, against a refusal of planning permission on a householder application any representations made on the application will be automatically forwarded to the Secretary of State. Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
