Thank you for your internet representation made on 10th December 2024 which has been recorded as an objection with the comments as follows:

OWPC72905

Objection based on:

- Over development and not in keeping with the area. The site has been overdeveloped already with extensions and outbuildings and a swimming pool. Elm Grove is a private road and properties within the road are set back. If this extension is granted it would be out of character and unaesthetically pleasing with the area.
- Surface water flooding. A further increase in the development of this property would lead to excessive surface flooding. Despite the information provided stating that (since the extension works in 2021), surface water will be redirected to a large soakaway at the rear of the property, this was before a 10-metre swimming pool was built and a change in impermeable material, therefore this will result in neighbouring properties being flooded.

Your views as made above will be considered before the application is determined.

Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
