Dear Sue,

Ok I understand your point of view now. However, that is quite an unusual approach and not one that I have come across before. To that end, it would have been helpful if this had of been made obvious to me from the outset as then I could have ensured all the relevant consultees had been notified (noting that we have not consulted Env Health) and briefed them accordingly.

I have just reviewed your Planning Statement, and I do note para 5.15 states "*To expedite this development as soon as possible, we are including additional documents to be assessed to avoid conditions and the delays to development that this brings.*" However, this does not make the case that you are now presenting. I also note that this section only referred to the CEMP and that there was nothing of this nature stated regarding the drainage.

As it is, we have only 6 working days to decide the application, and our policy is to only allow extensions of time in exceptional circumstances, and this is not such a circumstance that our Group Head of Planning would agree to.

You will therefore need to make separate applications for discharge of the outline conditions relating to the access (6), drainage (9), the CEMP (7), the Biodiversity Enhancement Strategy (8), energy (10) and lighting (12). I note that the CEMP condition is the only pre-commencement condition.
