Removal of existing chimney and existing side extension to the north and erection of a single storey side extension upto 3m height and the length of the existing building. The proposed upper floor side window is to be obscured and openable only above 1.7m height. To the south a small single storey extension is proposed, no taller than 3m, filling the gap from the two storey extension to the edge of the building. Proposed new window to the upper floor north side of the existing building, to be obscured and only openable above 1.7m height. All of the works to fall under the permitted development rights.
