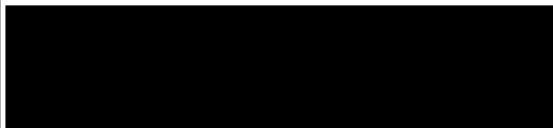

The site is comprised wholly of buildings and hardstanding (Developed land – sealed surface (u1b)), and is for a firstfloor extension that will not impact any ecology. Consequently, the Site has an ecological baseline of zero biodiversity units. Given the Site's zero baseline score in the SBM, the development is exempt from BNG and there is no requirement to deliver 10% net gain.
