The proposed railings will be finished in black, matching the style shown in the reference image. They will be installed to a uniform height of 450mm above the planter walls, creating a consistent and visually sympathetic appearance throughout the area.

Fixings will be positioned at regular, evenly spaced intervals to ensure both structural robustness and aesthetic coherence. In locations where planter walls contain existing artwork panels, fixing points will be adjusted where possible to avoid interference with the artwork and protect these important features. One artwork section spans four panels, and in this instance adjustments may not be fully achievable.

The design aims to deliver durability and practical function while remaining sensitive to the station's historic character and the valued artistic elements within the public realm. The product will be similar to the railings installed along the Seafront. AS Tooling Ltd, 231 Chichester Rd, Bognor Regis, PO21 5AQ, will supply the railings.
