I am just contacting in regard to the application for a loft conversion at 11 Chichester Road (BR/232/24/HH), of which an objection has been raised by Bognor Regis Town Council. Having reviewed the application, and spoken to Mr Sapozhnyk (applicant), we have resolved that the development would be considered acceptable with the removal of the proposed rear dormers.
