Details of the pre-application advice received

There is insufficient information to conclude whether the proposal could be supported. The principle of the scheme, minus the potential additional storey on the western side of the plot, would not seem wholly inappropriate given the existing context. However, the harms associated with the proposal such as obtrusive noise and highways impacts will need particular consideration and supporting evidence. It is thought that neighbouring residential amenity impacts could be addressed through the design process.
