Thank you for your internet representation made on 6th February 2026 which has been recorded as an objection with the comments as follows:

I feel a hardstanding with a pitched roof above 2.5m height is obtrusive in this particular setting. A garden building possibly OK made of wood (I still feel all the large garden buildings along that row should have needed planning permission as they look ugly from the street scene aswell. but a separate double brick built garage with tall pitched roof just off the highway blocking the view of the house when none of the houses along that row have one ? It would be a visual distraction for sure and would open the door for a myriad of similar applications of structures being built in front of a facade within the area. Next door would no doubt build one !

Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
