Thank you for your internet representation made on 2nd March 2025 which has been recorded as an objection with the comments as follows:

I'd like to log my objection. We are in a grade II listed area, which has been fervently defended by Arun district council when we have completed renovations, to ensure that all work is in keeping. Arun DCC did not allow the campsite development to go ahead and this house would be significantly more intrusive and visible, Plus this new build house will affect our 1st floor views from our house to the sea and we are concerned about the impact on the light into our house due to the two storey nature. Should the development go ahead we would want restrictions on working hours, plus guarantees that the dirt road will be maintained continually through the build, as the current residents who use the road pay to have it maintained. In winter particularly it quickly turns to a mud track, and that is with the current light vehicle usage,.

Your views as made above will be considered before the application is determined.
