Description of works: Erection of 1 No. two storey dwelling (self build) (resubmission following CM/15/24/PL). This application affects the setting of listed buildings, is a Departure from the Development Plan and is in CIL Zone 5 and is CIL Liable as a new dwelling.

Thank you for your internet representation made on 9th March 2025 which has been recorded as an objection with the comments as follows:

I write to object to this planning application.

The proposed development is a new build property which is totally out of character with the surrounding Grade II Listed properties. The footprint and height of the building would dominate its plot size and adversely affect the views and access to light of neighbouring houses. It would be intrusive in the surrounding agricultural landscape of the Climping Gap which is protected by National Trust Covenants. This area of predominantly coastal agricultural farmland has already suffered from extensive commercial development in recent years and is now at risk of being destroyed by creeping residential development. If this new build property were to be allowed, it would set a precedent for others to follow. With new housing estates already due to be built on nearby agricultural land to the north of this section of the A259, it is essential to protect what remains of the rural character and natural wildlife environment of the Climping Gap before it is lost forever.

Your views as made above will be considered before the application is determined.
