Description of works: Erection of 1 No. two storey dwelling (self build) (resubmission following CM/15/24/PL). This application affects the setting of listed buildings, is a Departure from the Development Plan and is in CIL Zone 5 and is CIL Liable as a new dwelling.

Thank you for your internet representation made on 11th March 2025 which has been recorded as an objection with the comments as follows:

OWPC74778

The Climping Neighbourhood Plan identifies the Brookpit Lane area and adjoining Kents Farm as Traditional Climping. Any new development in this area will need to respect its historic and visual context, including the scale and siting of any new development and construction materials will need to be chosen from a palette that respect the historic form of the village. This reapplication has made a gesture towards these requirements with some flint and quions added to the front elevation and 'hand made' clay tiles but it is only a gesture. The application remains the same as the previous withdrawn application. Its scale is too large, too modern, the windows proposed are UPVC. It will affect the setting of a Grade II listed building.

The land is agricultural land and in the protected Climping Gap south of the A259. The National Trust have covenants over all of this area and will need to be informed.

The postcode says the land is Flood Risk 1 we know that the 3 times the sea has breached it has come half way up the path to the camp site. That puts it within 100m of Flood Zone 3. It maybe that this site sits on higher ground (?) but it seems extraordinary that this is a suitable place for a new build and that no flood prevention measures have been included.

Your views as made above will be considered before the application is determined.
