The Council aims to make as many decisions as possible before the end of the statutory determination period, which in this case will be 5th January 2026. However, this is not always possible for a number of

reasons, including on-going negotiations or the scheduling of Planning Committees.

If you have not received a decision by 5th January 2026 or agreed in writing to extend the time in which the Council make a decision, you have 6 months in which to appeal to the Secretary of State. Your appeal (under Section 78 of the Town & Country Planning Act 1990) would be that the Council has failed to make a decision and you would be asking a Government Planning Inspector to make the decision instead. You can do this on a form which you can get from the Planning Inspectorate:

If you allow the Council extra time to make a decision on your application, and you disagree with the decision, you will still be able to appeal a refusal within 12 weeks from the date the decision was issued or if appealing a condition 6 months from the date the decision was issued.

This acknowledgement only relates to this application and not to any other types of planning application or other kinds of applications you have made, or may need to make to the Council, for example Building Regulations approval. You will need to carry out your own checks to determine whether any other consents or permissions are required.
