On further review the trees and shrubs on the borders were all overgrown and also a lot of them were dead.  
(We can get hold of a statement From surgeon of required)

They were causing damage to the boundary fencing and totally un maintainable.

The clients checked on more than one occasion from multiple sources including the council that the area was not apart of conservation and carried out the works professionally and efficiently.

To this end they are still working on clearing dead and overgrown shrubs but res assured some shrubs will be re planted on borders and boundaries to a higher standard to retain privacy and allow them to be managed properly in future.
