Description of works: Proposed part single, part double rear extension with roof terrace, two storey front extension, new side dormers.

Thank you for your internet representation made on 31st October 2025 which has been recorded as no objection with the comments as follows:

OWPC79575

Whilst not objecting to the application at this time, there is insufficient evidence shown on the drawings in order to make a judgement. The impact of the proposed extension and roof amendments will increase the likelihood of overlooking towards 7 South Drive, in particular from the large first floor balcony into our ground floor bedrooms, landing window and unobscured bathroom window on the first floor, all of which face west towards no. 9 South Drive. Elevation, section and even plan drawings do not clearly show the new elements of the build and their relationship to adjacent properties. In my opinion, this application cannot be considered without these critical elements being presented and assessed. Thank you.

Your views as made above will be considered before the application is determined.
