Thank you for your internet representation made on 2nd November 2025 which has been recorded as no objection with the comments as follows:

In addition to my previous comment, there does not appear to be any indication of landscaping within the planning application. There are large mature trees on the boundary between no. 7 and no. 9 South Drive, and between no. 9 and no. 11. Are these to be retained or removed? If they are to be removed, will any other privacy measures be implemented to retain the current status quo? If they are to be retained, how will the roots be protected when the new foundations are excavated for the proposed extension. They are VERY close to no.7 flank wall, and could pose a danger if roots are damaged. They are within the boundary of no. 9.
