Thank you for your internet representation made on 10th January 2026 which has been recorded as an objection with the comments as follows:

Once again, a revised plan for a house on this constrained site in The Grove Ferring has been submitted to Arun District Council.

Despite tweaking and lowering the proposed building this time, the fact remains that this is an inappropriate and cramped site and would impinge on existing properties, especially on those backing onto the site from Brook Lane.

This application should also be looked at in relation to 2 previous ones which were refused a planning consent, i.e. FG/46/21/PL and FG/13/23/PL, by Arun District Council and the Planning Inspector's major principles for refusal remain pertinent.

Your views as made above will be considered before the application is determined.
