Description of works: Erection of 1 No 1-bedroom self build house with associated parking & private outdoor amenity space. This application is in CIL Zone 4 and is CIL Liable as a new dwelling.

Thank you for your internet representation made on 19th January 2026 which has been recorded as an objection with the comments as follows:

I object to this application on the same grounds that the previous applications were refused (see FP/46/21/PL, FP/13/23//PL).

The site is insufficiently large to accommodate a dwelling and required amenity space without detriment to occupiers and neighbours alike.

Lowering the building 60cms below ground level will not change the fact that the site is much too small and this application, like its predecessors, remains an unduly cramped form of overdevelopment on a much too small site.

The proposed development has been moved even closer to the rear boundary of 28/30 Brook Lane than the previously rejected applications which were already deemed too close.

What are the drainage/flooding/subsidence implications for the proposed new dwelling as its ground floor will be below ground level and its garden space will be sunken? How will the stability of the right-of-way access across the north boundary (next to the sunken area) and the hard standing to the rear of 24's garden be kept structurally sound?

I respectfully request that our planning laws be applied and that this application should be rejected on the same grounds as its predecessors.

Your views as made above will be considered before the application is determined.
